TUITION AND FOOD PROTECTION PLAN

The Tuition and Food Protection Plan is a unique form of coverage that provides families with the opportunity to protect their tuition investment in Key Point Christian Academy. The Undersigned understands and agrees that the Student is enrolled for the entire school year and the Undersigned becomes liable for the entire year's tuition upon the signing of the Fees and Tuition Agreement.

PLAN COVERAGE:

- The right to coverage becomes effective upon registration for families that accept the Tuition and Food Protection Plan and pay the respective annual fee.
- Key Point Christian Academy will refund unused paid Tuition and Food fees for Plan A and Plan B contracts/agreements if canceled within 30 days of written notice.
- Plan C payment plan coverage allows the Undersigned to withdraw from the contract, without penalty, with 30 days of written notice detailing the reason for the student's withdrawal, along with proper documentation.
- If the Tuition and Food Protection Plan is elected and 30 days written notification of withdrawal is submitted to the Admission department, no penalty will be incurred on any payment plan.
- Coverage is effective at the moment of purchase (registration process) and expires on the last day of the current contract/agreement.

TERMS / CONDITIONS:

- A penalty equivalenA penalty equivalent to one month's tuition (Plan C tuition prices) will be incurred if the Tuition and Food Protection Plan is elected but failure to provide the 30 day written notice is not received.
- Any student that withdraws from the program prior to the first day of the contract/agreement will incur a penalty of one month's tuition (Plan C tuition prices), applicable to all payment plans.
- The written notice must detail the reason for the student's withdrawal, along with proper documentation.
- If the undersigned declines the Tuition and Food Protection Plan and withdraws from the contract, a penalty of two months' tuition (Plan C tuition prices) will be incurred and due during the withdrawal process.
- Selecting not to take the Tuition and Food Protection Plan waives any refund, for any reason.
- Registration, preschool supplies, academic materials, technology, and year memories fees are non-refundable.
- Prorated Tuition and Food fees will not be granted.
- The current contract/agreement begins on July 1, 2023, through May 31, 2024.
- For late enrollments, the contract/agreement will end until June 1, 2024.
- The Tuition and Food Protection Plan fee cannot be applied toward any other fees.
- The Tuition and Food Protection Plan is non-transferable between students or families.
- The Tuition and Food Protection Plan is required to be purchased during the registration process.
- No changes/modifications to the payment plan after the registration forms have been received and processed.
- Any discount given at the time of registration is voided and will be due during the withdrawal process.
- If the student is absent or expelled, Key Point Christian Academy will not refund any amounts paid and the Undersigned remains responsible for the entire school year's tuition and food fees.
- In the event that Key Point Christian Academy must be closed for any circumstances, the Administration will attempt to accommodate the needs of the children's education, until the end of the current school year's contract/agreement.
- In the event that the school must have its campus closed for more than two weeks, our educational program will continue with
 distance learning until campus classes resume and the undersigned will be responsible for full tuition payments as scheduled
 until the end of the contract/agreement.
- Any overdue account balance after 90 days will be sent to RFGI, our third-party collections agency. Collection fees will be added to your account.
- Refunds are only applicable for Plan A or Plan B if the Undersigned has elected to accept and purchase the Tuition and Food Protection Plan.

PERIOD OF COVERAGE

The policy is effective at the moment of purchase (registration process) and expires on the last day of the current contract/agreement.
